Michael Darga, John Kelly and Scot Martin are stepping down from the board at the end of this year There are five-3 year terms and one- 1 year term

The ballots are being sent to Susan Thompson as Laura Wagner is running for reelection

c. New Hire/upcoming hire updates (*note title updates)

Three interviews for the Watershed Planner (Water Trail) position held. One very strong candidate interviewed. Position not formally offered as of yet. The funding for the position is provided by the National Kidney Foundation

d. Board Development-Training: The Thank You

Lara Edwards conducted first board training about thanking members She calls two members randomly to say "thanks"

The longer a person is involved in the organization, the more revenue generated due to that membership

If a person is involved for five years, they usually stay involved long term

Looking for board volunteers to make phone calls to new members

e. 2020 Budget Update/Team Reviews

Working on the 2020 budget and it is going to the Finance Committee. The managers are also getting involved in their working on their own budgets

f. Wayne County Property Sales- Update

The sales of Newburgh and Wilcox Mills are going to be sent to the Wayne County Commission in November 2019. Save Hines Park is hosting an informational meeting at Schoolcraft College Vis-Ta-Tech Center on November 18, 2019 at 6:30pm

g. Upscaling Restoration Program Opportunities

Earned revenue with Restoration Rain Smart (NPS 319 Grant funds) and working with other watersheds to bring Rain Smart branding to all area watersheds. Matthew Bertrand and Cyndi Ross are taking the lead and asking for funding through ERB. The goal is to build maintenance programs for Green Infrastructure. Potential connection with Good Will Industries to develop and broaden a GI workforce.

h. Monitoring Program funding

Working with Sally Petrella on monitoring funding: benthic, fish and Frog and Toad monitoring. Need \$40,000/year for benthics. The Stonefly and fall bug hunt for done for \$20,000. Approaching the individual communities to help fund the monitoring by pledging \$550/site. Did not ask the communities for Stonefly Search funding; the ARC has provided \$5000 over the last three years. Received funding commitments from the Cities of Southfield, Novi, Livonia; Plymouth and Northville Townships, and Washtenaw County for the fall bug hunt. Some communities that were asked to financially support declined. ARC pledged to give \$10,000, but this amount cannot be counted on each year. Stonefly is funded for 2020. Requesting funding for the watershed report card that will go to support the reporting and monitoring.

i. Fort Street Bridge Park- Updates

The construction is underway, selecting a sculptor, working with Friends of the Detroit River, Downriver Linked Greenways to develop a gateway feature funded through the Ralph C. Wilson Foundation. FOTR will assume fiduciary responsibilities.

j. Additional issues from the floor

FOTR will be joining other organizations for the Global Cleanup on April 22, 2020 (50th Anniversary of Earth Day). This event is also going to be a Rouge Rescue kick off

Motion to support a resolution that the FOTR will collaborate with other watersheds to support all watersheds equally well; and encourage the Executive Director to continue pursuing these collaborations made by DN, seconded by MM. Motion carried
