- a. May Day for Your River Emergency Appeal had a final total of \$38,916.90

- c. Rouge Gateway Greenway Phase II / Fort Street Bridge Park Phase II Update
  - FOTR and Mark Allan & Associates interviewed three general contracting firms on May 31, 2025. FOTR is working with our architects/engineers and Wayne County Parks to finalize the selection.
  - ii. We anticipate that construction on Fort Street Bridge Park Phase II could start in June/July. Construction on the Rouge Gateway Greenway Phase II will need to wait until the fall due to restrictions on when we can start clearing trees from the site.
- **d.** Together Together will finalize Strategy Phase of the Strategic Plan by the end of July and will commence Implementation Phase in August
- e. Lobbying/Advocacy
  - i. Updated "Welcome to the Watershed" information packets are being sent to legislators who represent the Rouge.
  - ii. FOTR is working with HRWC and CRWC to host a "Watershed Lunch and Learn" in Lansing for legislators. The goal is to introduce the Rain Catcher's Collective to legislators and garner support for the initiative.
